

Since the publication of Redesigning America's Community Colleges, **CCRC** has studied the implementation of guided pathways at 120 colleges nationally.



To progress from GP 1.0 to GP 2.0, we recommend a focus on reimagining the program onboarding experience so that all students are helped to explore, enter, and gain momentum in a program of study.

Why focus on program onboarding?

- Students who gain early momentum in a program are much more like to graduate and transfer.
- Too many students drop out by year 2, and many who persist are not in a program of study aligned with their job and transfer goals.
- Reimagining onboarding focuses on GP pillar 2, which builds on pillar 1 and provides a foundation for pillars 3 and 4.

Reimagining program onboarding requires three key mindsets

- 1. Choosing a program is a developmental process that can take up to a year
- 2. Providing career and program information at the start isn't enough.
- 3. Colleges need to tailor onboarding experiences to provide different students the support they need.

Data expectations

- Focus on data to inform and motivate whole-college guided pathways implementation efforts
- Quantitative data will include program-level enrollment and course-taking
- CCRC will provide support to complete data exercises prior to start of institute



Applying

Who should apply?

- Colleges that have not received significant support to implement guided pathways
- Cross-functional guided pathways teams that want to move from GP 1.0 to GP 2.0 <u>OR</u> that have laid a groundwork and want to start on GP 1.0

Elements of a strong application



Commitment by college leadership to implement changes college-wide and at scale



Compelling articulation of how the institute will support your college's redesign work



Clear rationale for the members of a cross-departmental, multilevel institute team (including faculty)

Important dates

Before February 8, 11:59 PDT

Submit the Google form application

- College and team information
- Short-answer responses about your college's experience with guided pathways and interest in the institute

Last two weeks of February

CCRC conducts short interviews with teams under consideration

Early March

Notification of selected teams
